Turn in a printed copy no longer than 2 pages. The critique must include whether or not the survey or its administration might be statistically biased, and if so, what type of bias is exhibited. You may include an improved version of the survey to clarify your comments. Base your critique at least on our text. If you use other valid sources, include citations and a brief bibliography; if you use web information, provide the url.

Anonymously complete the separate page provided. The pledge on this page indicates your completion of this portion. You will be given a participation grade for this portion.

3. Food Acquisition Survey Evaluation:

In a short paragraph on the back of this page, evaluate how well the survey from Part 1, Option A could be analyzed to answer the following questions. Answer this even if you did not complete the survey. Provide sample survey questions if the Survey in this assignment would not be adequate. This portion is not anonymous and will be graded for content.

- Q1. How do shoppers travel to their main store and how far do they travel to get there?
- Q2. In what type of store (eg., supermarket, mass merchandiser, convenience store) do U.S. households typically shop for groceries?
- Q3. Do store and travel mode differ by participation in food assistance programs or food security status? (These questions are explicitly stated in the report "Where Do Americans Usually Shop for Food and How Do They Travel To Get There?", EIB-138. There is no need to read the report.)
